** The vacancy for Lab. Assistant, Cat. 25, is reserved for Hearing Handicapped person only and Educational Qualification is Matriculation with Science plus two years diploma in medical Lab. Technology (DMLT). No candidate is found to fill-full the above criteria. As such no candidate, who have applied for the above post, is found eligible. If any candidate consider himself fulfilling the above criteria may represent in person with original documents to this RRB in any working day before 15.11.08. His case will be considered accordingly for appearing in the ON LINE examination dated 16.11.08.

The Call letters for above ON-LINE examination have been issued by U.P.C. (Post) to all eligible candidates. The eligible candidates who don't receive their original call letters, can apply personally in RRB, Jammu office for their duplicate copy of call letter or for any correction in the call letter for above categories/ posts on above scheduled date and time along with one photograph as pasted on their application form and obtain duplicate call letter to appear in the On-Line examination.

The rejection advise to ineligible candidates has also been sent by post (U.P.C.).

Request for duplicate call letters will not be entertained for above examination **on the day of on line examination**. Request for change in date, time at place of above examination will not be considered.

Note: 1. The candidate may have to stay for more than one day, therefore they should make arrangement and come prepared accordingly. No allowance for the same will be paid.

2. The candidates, **EXCEPT for cat no.22, LAW ASSISTANT**, must bring all their original educational & technical certificates, mark sheets, latest caste certificates on advertised profarma, proof of experience, certificate for proof of date of birth, NOC from present employers where applicable etc. The successful candidates will have to stay back for one day for document verification. The intimation regarding this will be given to successful candidate after the exam. The document verification for cat no.22 Law Assistant will be afterward date for which will be announced after Viva – Voce test, therefore they need not to bring original documents for verification.

3. In the unlikely event of the On-line exam. (Computer exam.) may not take place due to some technical snags, in this event, RRB may decide to hold written examination. The candidates must come prepared for this.
