The candidates are required to attend the office of Railway Recruitment Board, Jammu as per dates of documents verification indicated above, with their original certificates and marks sheets (semester wise / year wise) of Educational /Technical qualifications, Caste certificates, Proof of age etc. and also their Photostat copies attested by a Gazetted Officer, for verification. The candidates belonging to OBC Community, should bring original caste certificates in the prescribed format of the central Govt., issued for the current year and valid on the date of verification of certificates, the caste certificates should be current and should have clause of non-creamy layer. Those candidates, who fail to turn up on the due date or report without proper certificates, their candidature will be cancelled. The candidates who do not possess the requisite qualifications, as noted while document verification, their candidature shall stand cancelled / rejected.
